A. PERSONAL INFORMATION

Dr. Abdul Azim islahi, born on 20.4.1950, has studied Arabic and Shariah Sciences at Madrasah-Al-Islah, a noted seat of learning in India. He graduated from University of Lucknow and received M.A. (Economics) and Ph.D. from Aligarh Muslim University, Aligarh. His Ph.D. thesis is on "Economic Views of Ibn Taimiyah".

Dr. Islahi started his teaching career at King Abdulaziz University, Jeddah, in 1977 where he taught Economics with Islamic perspective To the students of Engineering. He was promoted to Assistant Professor in 1982 and worked on the same position till 1988. In 1989 he joined Department of Economics, Aligarh Muslim University, Aligarh, as Associate Professor where he taught History of Islamic Economic Thought at the post-graduate level. He has also guided there Ph. D. researches on Islamic economics, banking and finance. Presently he is working at the Centre for Research in Islamic Economics, King Abdulaziz University, Jeddah, Saudi Arabia. He knows five languages, Arabic, English, Hindi, Persian and Urdu.

B. RESEARCH AND ACADEMIC WORKS

Dr. Islahi has been engaged in research and teaching of the History of Islamic Economic Thought and is considered as an authority on the subject. Following is a brief account of his major works in this area:

- 1. His most outstanding work is "Economic Concepts of Ibn Taimiyah" (Islamic Foundation, UK, 1988, republished in 1996). The work attracted appreciation by reviewers and citations from the scholars.
- 2. The Center for Research in Islamic Economics published his three works, *Economic Thought of Ibn al Qayyim* (1984), *History of Islamic Economic Thought: A Bibliography* (1997) and *Economic Thought of Al-Ghazali*(1998, in coauthorship of Dr, S.M.Ghazanfar). All are refereed works. Earlier he authored History of Economic Thought in Islam: A Subjectwise Survey (1996) published by Aligarh Muslim University.
- 3. In 1999, Dr. Islahi published a valuable work in Urdu, *Share Bazar mein Sarmayahkari: Maujudah Tariqa-i-kar aur Islami Nuqta-i-Nazar* (Iinvestment in the Share Market From the Islamic Point of View), which is the only work of its nature in this widely read and spoken language on the sub-continent.
- 4. He has also presented a collection of Ibn Taimiyah's Economic Texts, *Al-Nusus Al-Igtisadiyyah Al-Mukhtarah Min Kalam Shaikh Al-Islam Ibn Taimiyah* (2001).
- 5. His many research papers and articles have appeared in professional and refereed international journals such as *History of Political Economy* (North Corolina, USA), *History of Economic Ideas* (Pisa, Itali), *Journal of Research in Islamic Economics* (Jeddah), *Journal of Islamic Economics* (Malaysia), etc.

- 6. Dr Islahi has developed and introduced a course of study on History of Islamic Economic Thought at the postgraduate level in the Department of Economics, Aligarh Muslim University, Aligarh. In 1992 he organized a Workshop on Islamic Economics at Aligarh Muslim University and the next year in 1993, the First all India Conference on "Relevance of Islamic Economics in the Indian Context" at Bangalore, the capital of Karnataka state of India. In October 1999, he organized national level seminar on "Islamic Economics: Issues and Challenges" at Jamia Millia Islamia, New Delhi.
